I have been working in economic and social development since the mid-1980s, initially with British local government and since 1989 internationally.

At the World Nuclear Association I am researching the international nuclear supply chain to identify key actors and possible "pinch points" of supply insecurity that currently exist or are likely to develop. I am also looking at expanding 'local content' options with the major component and equipment suppliers. The work is published in the WNA Market Report.

As Project Director at HTSPE Ltd I was responsible for business development, designing and delivering major projects of technical assistance and training on behalf of the UK government, the European Commission, Asian Development Bank and the World Bank. Project have included:
